## **BUSINESS ANALYTICS**

Give users of all skill levels a robust reporting engine that combines ad hoc reporting, interactive visual analytics, scheduling and distribution. RISKMASTER Business Analytics lets you access, analyze, schedule and share information with an easy drag-and-drop reporting tool and eye-catching dashboards that provide a comprehensive view of your processes and trends. You can choose predefined report templates or easily create new reports that allow you to query and manipulate results. When creating queries you can limit the results to a ranked subset — for example, return only the top 50 values for a particular measure.

You can also easily mine your data with our Internet-style search tool. Business Analytics Explorer combs your data to determine which data store can supply the answer to a given question.

## **LEGAL SOLUTIONS SUITE**

Work strategically with outside counsel to manage legal expenses and optimize outcomes, while ensuring efficiency and consistency. Available Web-based modules in this integrated litigation management component include law firm evaluation and benchmarking, electronic case assignments, e-billing, automated bill review, guideline monitoring, budgeting, planning, results tracking, document management and reporting.

## **INTEGRATED DISABILITY MANAGEMENT**

Seamlessly add modules to manage work-related and non-occupational disabilities. You can

combine the Workers' Compensation component with the optional Non-Occupational Disability module, which includes both Short-Term and Long-Term Disability, as well as FMLA. The Case Management module lets nurses, examiners and bill analysts share information that assists in the appropriateness of care, creating a collaborative automated workflow.

## **PROPERTY MODULE**

Track and maintain inventory for property claims. Demographic information tracked includes COPE (Construction, Occupancy, Protection and Exposure) as well as location address information. User-defined supplemental data fields can be easily configured to capture additional information.

## **MEDIA CONTENT MANAGEMENT**

Gain browser-based document management and a single point of access to notices of loss, medical bills, police reports and other documents with this optional component. You can scan documents directly to the appropriate folders, reducing paper use, and immediately capture and store recorded statements. Additional components include ScanPlus, Email Monitor, Directory Monitor and Workflow.

ScanPlus provides image manipulation and cleanup capabilities. Email Monitor supports centralized email boxes where outside users can forward messages with attachments, which are then imported directly into RISKMASTER



Accelerator records. Directory Monitor checks network folders to import new documents into the system, and is useful for network copiers, fax servers, FTP files and documents produced by third-party applications. Workflow uses rules-based processes to determine where to send notifications at any point in the process. Extended capabilities include the ability to terminate and re-initiate workflow, suspend the process, return to a previous step and push to another workflow.

### **MMSEA SECTION 111 REPORTING**

Stay in compliance with RISKMASTER's Medicare, Medicaid and SCHIP Extension Act of 2007 (MMSEA) Template. You can extract data from RISKMASTER Accelerator or filings to Centers for Medicare & Medicaid Services (CMS) and process the files returned by CMS. This is also known as Medicare Secondary Payer. Using the MMSEA Template, you can schedule, import and export MMSEA jobs from within RISKMASTER Accelerator.

#### **HEALTHCARE SYSTEM BRINGS WORKERS' COMP IN-HOUSE, CUTS CLAIMS IN HALF**

To gain control of its claims data, one of the largest nonprofit healthcare organizations in the United States decided to self-administer its workers' compensation program. The organization moved claims processing from a TPA to an in-house team using RISKMASTER.

Since then, lost-time cases have dropped from between 150 and 250 cases a year to an average of 75. Benefit payments for lost-time care have dropped by 73 percent, and the organization has also seen a 50 percent reduction in workers' compensation claims.
